#### **BYLAW NO. 05-2023**

#### **TOWN OF MARSHALL**

# A BYLAW OF THE TOWN OF MARSHALL TO FIX THE RATE(S) TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

The Council of the Town of Marshall, in the Province of Saskatchewan, enacts as follows:

- 1. The Municipality may, by Bylaw, ration or limit the amount of water furnished to any and/or all consumers should circumstances deem to warrant such action.
- 2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached.
- 3. Accounts for water service shall cover a period of TWO (2) successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of sixty (60) days from the date on which such accounts are rendered. If an account is not paid within sixty (60) days, the water service may be disconnected.

When the water service is disconnected, it shall not be reconnected until ninety (90) day arrears have been paid, together with a \$50.00 reconnection fee to cover the Town's expenses. If the Municipal employee is required to turn on the said water service outside the Municipal employee's regular working hours, the fee shall be an additional \$25.00 for a total of \$75.00.

- 4. A penalty of **7.5**% will be added to all water and sewer accounts in arrears on the first of each month.
- 5. All septic tanks are pumped out every two years at no cost to the owner. Septic tanks must be accessible to the Town employees or contractor before the tanks will be pumped or, it is up to the individual owner to find alternative means to have their tank pumped out at their own expense.
- 6. The sewer system on private property is the owner's responsibility.
- 8. Bylaw No. 09-2019 is hereby repealed.

THE rates, charges, tolls or rents contained in this Bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or the 1<sup>st</sup> day of January, 2024, whichever is the latter.
